

AWARD OF CONTRACT FOR FURNISHING AND DELIVERY OF ONE (1) TOYOTA MODEL 50-8FGU25 FORKLIFT OR EQUIVALENT FOR THE SOMERSET COUNTY FACILITIES AND SERVICES DIVISION

WHEREAS, the Chief Financial Officer of Somerset County has certified in writing the availability of funds for the purposes set forth in this Resolution, such certification on file with the Clerk of the Board, and such funds are provided for in the duly adopted budget of the County of Somerset, line item (04-215-251-45-165-804) \$44,659.53; and,

WHEREAS, four (4) sealed bids were received, opened and read in public on June 24, 2025, at 3:30 PM prevailing time for Furnish and Deliver One (1) Toyota Model 50-8FGU25 Forklift or Equivalent for the Somerset County Facilities and Services Division, Contract #CC-9097-25; and,

WHEREAS, the bids were reviewed by the Director of Facilities and Services, and it was determined that the low bid as submitted by Cincinnati Lift Truck & Battery Service, LLC is considered non-responsive due to failing to meet the County specifications for the lifting capacity requirement (Specifications section 1.2); and,

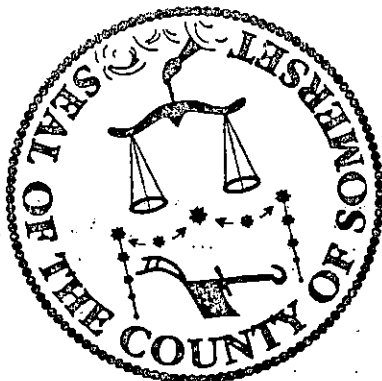
WHEREAS, the Director of Facilities and Services determined the second low bid as submitted by Octane Forklifts, Inc. is considered non-responsive due to failing to meet the County specifications for the height and lifting capacity requirements (Specifications sections 1.1 and 1.2); and,

WHEREAS, the Director of Facilities and Services determined the third low bid as submitted by Maintainco, Inc., 65 E. Leaning Street, South Hackensack, NJ 07606 meets the requirements of the County specifications for:
