

**SOMERSET COUNTY PARK COMMISSION
RESOLUTION AWARDING A ONE-YEAR CONTRACT
WITH ONE (1) ONE-YEAR OPTION TO EXTEND
FOR ARMORED CAR SERVICES
CONTRACT NO. PCC-0034-25**

WHEREAS, the Treasurer of the Somerset County Park Commission has certified in writing the availability of funds for the purposes set forth in this resolution, such certification being attached hereto and made part of hereof, and such funds are provided for in the temporary budget of the Somerset County Park Commission: \$11,911.50 (31-201-20-850-103-290); and

WHEREAS, the Somerset County Purchasing Office did on July 7, 2025 advertise on the Park Commission website www.somersetcountyparks.org, on the Somerset County website www.co.somerset.nj.us, and in the Courier News for bids for Armored Car Services; and

WHEREAS, one (1) sealed bid was received, opened, and read in public on August 8, 2025 at 4:00 pm prevailing time for Armored Car Service, Contract No. PCC-0034-25; and

WHEREAS, the bid was reviewed and it was determined that the bid as submitted by Eastern Armored Services, Inc., PO Box 8733, Trenton, NJ 08650 meet the requirements of the Park Commission specifications; and

WHEREAS, Eastern Armored Services, Inc., (hereinafter the "Vendor") submitted the lowest responsible bid(s) on for Armored Car Service.
